Heart Rangers – Bill Eck gave a report on the Heart Rangers activities. He announced a training and recertification of current rangers. Volunteers were also sought.

Dance Committee – Ken Sutter announced the Renaissance Rockers will be playing for the dance on January 21st. A new band from Corpus Cristi, Tumble Dry Low, will be playing on February 4th and encouraged everyone to come and support them.

Craft Show – Linda Kling thanked all her committee and volunteers and reminded everyone of the craft show on January 21st.

Article 5, Section 9 – Board authority to spend up to \$1000. Vote to increase the amount from \$1000 to not to exceed \$2000.

Alice Broers announced the HVR Talent, No Talent Show for March 12th and encouraged members who wanted to participate to sign up on the sheet on the bulletin board.

January 13, 2012

Members in attendance: Jim Reiland, Larry Woodard, Tom Forbish, Karol Lippert, Lucy Cagler, Nathan Holland, and Mike Yost. Bobbie Bradshaw and Joe Roberts were absent. Minutes of the December 30, 2011 meeting were approved.

Reports of Officers:

Tom Forbish – he has received a string of industrial mini lights which will be tried on one of the boulevard palms in an attempt to save money and beautify the boulevard.

** AEP will not do anything on their poles – we would have to hire contractors to do the work.

** The books have been closed for the year and have been given to the accountant.

Reports of Directors:

Lucy Cagler – It has been noted that members are allowing dogs to be on the new parking lot and landscaping. Lucy moved that signs be pursued for posting stating that no pets be allowed on the new landscaping, seconded by Larry Woodard, motion carried.

Committee Reports:

**NOTICE TO MEMBERS
OF HIDDEN VALLEY RANCH
PROPERTY OWNERS ASSN.**

In accordance with ARTICLE XI, AMENDMENTS, Section 1, *Power of Members to Amend Bylaws*, you are hereby notified that the following proposed bylaw amendments will be presented for approval at the **February 11, 2012**, general membership meeting of Hidden Valley Ranch Property Owners' Association.

FIRST PROPOSED BYLAW

CURRENT BYLAW:

ARTICLE III, List of Membership
SECTION 1. *Membership List*. A list of members who own one or more lots and whose assessments are fully paid shall constitute the membership of this property owners' association and only such members shall be eligible to vote. A member may have ownership rights either by Warranty Deed or Contract for Deed.

CHANGE: Omit in its entirety and submit the following therefor:

PROPOSED BYLAW:

ARTICLE III, Members in Good Standing
SECTION 1. *Members in Good Standing*. A member is in good standing and eligible to attend and vote at all association meetings if said member:

- a.) Is an owner of real property in Hidden Valley Ranch Subdivision; and
- b.) Has paid all annual dues assessments and special assessments as determined by the Hidden Valley Ranch Board of Directors; and
- c.) Has not been found to be in violation of any covenant, stipulation or restriction of Hidden Valley Ranch Subdivision by the association board of directors and/or a court of law.
(Underlined section indicates proposed changes.)

REASON FOR CHANGE: To eliminate unnecessary and irrelevant language from the Bylaws and clarify the description of members in good standing.

SECOND PROPOSED BYLAW

CURRENT BYLAW:

ARTICLE V. Officers/Board of Directors.
SECTION 9. Maximum Amount of Expenditures. Board expenses in excess of ordinary expenses routinely incurred shall not exceed \$1,000.00 each unless approved by the membership. *Amended January 2002.*

CHANGE: Change the amount of \$1,000.00 to \$2,000.00.

PROPOSED BYLAW:

ARTICLE V. Officers/Board of Directors.
SECTION 9. Maximum Amount of Expenditures. Board expenses in excess of ordinary expenses routinely incurred shall not exceed \$2,000.00 each unless approved by the membership.
(Underlined section indicates proposed changes.)

REASON FOR CHANGE: To allow the Board of Directors to more efficiently handle the association financial responsibilities because of the current rising cost of expenses.

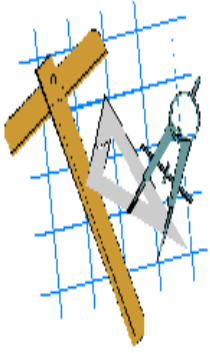

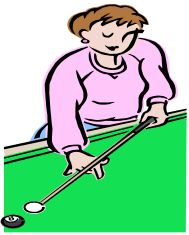

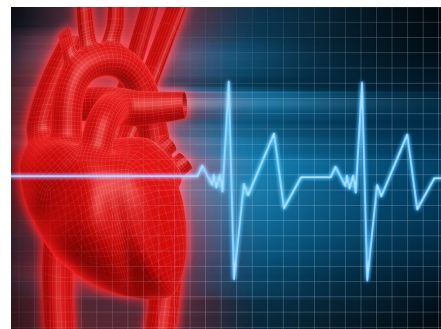
