**H-I-G-H-L-I-G-H-T-S OF MINUTES OF
BOARD OF DIRECTORS MEETING**

February 3, 2012

The meeting was called to order at 9:00 AM by President Jim Reiland. Roll call indicated a quorum was present. Members in attendance: Jim Reiland, Larry Woodard, Tom Forbish, Karol Lippert, Lucy Cagler, Nathan Holland, Jim Moore, Rick Radl and Mike Yost.

Minutes of the January 13, 2012 meeting were approved.

Reports of Officers:

Tom Forbish – The flood lights on the palms will be replaced with CFL colored lights which are much more efficient. He is still researching replacement lighting for the flag pole.

Larry Woodard – He attended a workshop on citrus greening and will be taking the information to the February park meeting to inform the membership on how to protect their citrus trees.

Karol Lippert – New key agreement forms are made for the disbursement of keys. All key holders will be required to complete an agreement.

Reports of Directors:

Lucy Cagler – Plants have been purchased and planted on the west side of clubhouse.

** The video cabinet is now in place and working well.

** Rust has been noted on the canopy over the shuffleboard court which needs treatment and repainting. The wood benches are also needing attention.

Jim Moore -- Brought Bill Eck forward to address the Board regarding the need to purchase amplifier bases for the Heart Rangers' pagers. An anonymous Heart Ranger will donate up to \$400 towards the units which cost \$62 each. The AED's are needing new batteries and/or replacing the oldest unit which was manufactured in 1998. Bill will also present the amplifier which can be used to amplify cell phones to the membership at the February meeting.

Mike Yost – Reported the carpeting has been ripped up on the west end of the putting green as well as the flags. This is an issue for maintenance.

Nathan Holland – The carpeting on the stage needs to be replaced. Lucy Cagler moved to look into new carpeting for the stage, seconded by Tom Forbish. Lucy amended the motion to obtain prices for wood flooring, laminate and carpeting, seconded by Rick Radl, motion carried. Ken Sutter and Ron Kling will obtain estimates.

Committee Reports:

Long Range Planning Committee -- Ron Kling wants to present a survey to the membership at the February meeting for determining which projects are important and that they would like to have the committee proceed to obtain facts and figures. It would be of no value for the committee to waste time and effort on projects that the membership does not feel are important.

Issues from the floor:

Mary Ann McElheron addressed a concern she had presented to the Board regarding a conflict of interest of a board member serving as an alternate on the Architectural Committee. Our parliamentarian, Bill Anderson, researched Robert's Rules of Order. It was concluded that an officer can be on a committee, but

cannot chair said committee. Nothing in our Bylaws addresses this issue.

Nona Dorholt addressed a concern about the library use stating that approximately six years ago a membership vote was taken that the library will to be used solely as a library. A letter from Judy Fink was read also regarding the use of the library. Since previous action has been taken on this issue, Karol Lippert will research the minutes.

President Reiland, has checked with a Mission veterinarian and Nathan also checked with one concerning any possible harmful effects from the use of cayenne pepper on the new landscaping to dissuade pet use since some pet owners are not respecting it. According to both veterinarians the pepper is not toxic or harmful to the pets, but can cause sneezing. Meeting adjourned at 10:36 am.

Reports of Officers:

Tom Forbish – AEP has work order for the lighting on the northeast corner of parking lot.

** The CFL colored lights have been installed on the boulevard.

** All assessments have been paid.

Reports of Directors:

Lucy Cagler – Still working on the rust issue on the canopy poles over the shuffleboard court and refinishing the wood benches.

Unfinished Business:

Long Range Planning Committee -- Ron Kling presented a survey to the Board which he will introduce to the membership at the meeting tomorrow for determining which projects are important to the membership and for which they would like to have the committee proceed to obtain facts and figures. Lucy Cagler moved to accept the survey form, seconded by Larry Woodard, motion carried. It will be presented to the membership at the meeting tomorrow.

Dog issue – Rumors are going around and Ken Sutter is being greatly threatened if cayenne pepper is spread on the rocks. All responsibility falls directly on the Board, Ken was asked to order the pepper. This issue will be addressed at the park meeting tomorrow.

Nathan Holland postponed the issue until the membership has been informed, seconded by Rick Radl, motion carried.

Judy Hamilton addressed the Board again on the quorum issue. Bill Anderson, parliamentarian, explained that the Bylaws specifically says a quorum can only be dispensed of if you lose a quorum in Article 5. If you lose the quorum you lose the power to handle questions or motions and the meeting has to be adjourned, no business can be conducted. Roberts Rules say the same thing.

Library issue – Lucy found the minutes from February 14, 2009 park meeting wherein the membership by a majority show of hands wanted the library to be a multi-function room. The issue will be pending the results of the long range planning committee survey.

Meeting adjourned at 10:15 am to go into executive session.

** AEP will downgrade our lights at no charge since we qualify under a municipality. This change will save us approximately \$800 a year.

Reports of Directors:

Mike Yost – Noted there wasn't any garbage cleanup after entertainment.

Rick Radl – Sat in on Architectural Committee Meeting noting they are changing some of the wording in their packet of materials.

Lucy Cagler – Water leak at the annex has been resolved. Roof is dirty, needing washed. This is a maintenance project.

Committee Report:

Long Range Planning Committee -- Ron Kling update the Board regarding the proposed new building project.

ByLaw Committee – Bill Anderson and the committee was given direction from the Board regarding a change in the bylaws to reflect a quorum change to read 250 needed for a quorum.

Audio Committee – Bob Erickson addressed the board regarding the stage floor covering. The Maintenance Committee is in the process of obtaining cost estimates.

New Business:

Tom Forbish moved that we offer to pay Jan Gottberg for the repair or purchase of a new blood pressure cuff, seconded by Lucy Cagler, motion carried.

Suggestions and Concerns:

A concern was noted that the building's doors were locked during the chicken dinner which is a safety issue and they should not be locked during any events.

The need for automatic handicap door controls was brought to the attention of the Board. The Board needs facts and figures before a decision can be made.

Meeting adjourned at 9:28 am to go into executive session.

NOTICE TO MEMBERS OF HIDDEN VALLEY RANCH PROPERTY OWNERS ASSN.

In accordance with ARTICLE XI, AMENDMENTS, Section 1, *Power of Members to Amend Bylaws*, you are hereby notified that the following proposed bylaw amendments will be presented for approval at the **March 10, 2012**, general membership meeting of Hidden Valley Ranch Property Owners' Association.

FIRST PROPOSED BYLAW

CURRENT BYLAW:

ARTICLE III, List of Membership
SECTION 1. *Membership List*. A list of members who own one or more lots and whose assessments are fully paid shall constitute the membership of this property owners' association and only such members shall be eligible to vote. A member may have ownership rights either by Warranty Deed or Contract for Deed.

CHANGE: Omit in its entirety and submit the following therefor:

PROPOSED BYLAW:

ARTICLE III, Members in Good Standing
SECTION 1. Members in Good Standing. A member is in good standing and eligible to attend and vote at all association meetings if said member:

a.) Is an owner of real property in Hidden Valley Ranch Subdivision; and

b.) Has paid all annual dues assessments and special assessments as determined by the Hidden Valley Ranch Board of Directors; and

c.) Has not been found to be in violation of any covenant, stipulation or restriction of

Hidden Valley Ranch Subdivision by the association board of directors and/or a court of law.
(Underlined section indicates proposed changes.)

REASON FOR CHANGE: To eliminate unnecessary and irrelevant language from the Bylaws and clarify the description of members in good standing.

SECOND PROPOSED BYLAW

CURRENT BYLAW:

ARTICLE V. Officers/Board of Directors.
SECTION 9. Maximum Amount of Expenditures. Board expenses in excess of ordinary expenses routinely incurred shall not exceed \$1,000.00 each unless approved by the membership. *Amended January 2002.*

CHANGE: Change the amount of \$1,000.00 to \$2,000.00.

PROPOSED BYLAW:

ARTICLE V. Officers/Board of Directors.
SECTION 9. Maximum Amount of Expenditures. Board expenses in excess of ordinary expenses routinely incurred shall not exceed \$2,000.00 each unless approved by the membership.
(Underlined section indicates proposed changes.)

REASON FOR CHANGE: To allow the Board of Directors to more efficiently handle the association financial responsibilities because of the current rising cost of expenses.

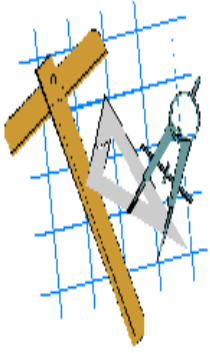
