PROCEDURE TO BRING AN ISSUE BEFORE THE
BOARD
AND/OR THE MEMBERSHIP

Any member of the association wishing to bring an issue before the <u>general membership</u> MUST present the request to the association president at least five (5) days prior to the meeting to allow time to determine all the facts concerning the matter in accordance with the H.V.R.P.O.A. Special Rule B.

Any member of the association wishing to bring an issue before the <u>board of directors</u> MUST present the request to the association president at least three (3) days prior to the meeting to allow time to determine all the facts concerning the matter in accordance with the H.V.R.P.O.A. Special Rule A.

All board meetings are open to members, except when the matter at hand is of a sensitive nature and needs to be handled by board members only.

#### HIGHLIGHTS OF MINUTES OF GENERAL MEMBERSHIP MEETING

March 10, 2012

The meeting was called to order with 308 members present; number required for a quorum was 261.

The treasurer's report as of February 29, 2012, was read by Tom Forbish as follows: Checking account balance \$131,432.00; reserve account balance \$66,800.00; February income \$7,498.00; February expenses \$9,080.00; net income (loss) (\$1,582.00). Total activity income for January/February reported a net figure of \$7,960.00. The volunteers who contributed their time and effort were recognized for a job well done.

General announcements and information:

>>>Elite Ambulance has donated refrigerator magnets for the membership;

>>>The NuStep Committee intends to earn money to purchase a much-needed additional machine. The Bicycle Club announced they would donate \$300.00 toward the purchase of the additional machine.

>>>The Architectural Committee advised that Hidalgo County is continually changing the rules and regulations and that anyone making changes to their lot should contact the committee first.

>>>The Long-Range Planning Committee announced the results of the survey which indicated that the number one choice of future projects was to move forward with the proposed activity building;

>>>The Women Together Abuse Center raffle project and lasagna dinner raised a total of \$1,302.00;

>>>The Creative Sewing group donated twelve wall hangings for the clubhouse so that one can be on display each month;

>>>Members should complete the "Summer Lot Cleanup" form and return to the office. A \$100.00 fine plus \$25.00 will be assessed for members not in compliance with maintaining their property;

>>>A street dance will be held March 25 at 3:00 p.m.; >>>Members who would like to volunteer their expertise for the proposed activity building construction were asked to sign the sheet posted on the board.

March 9, 2012

**G**eneral announcements and information:

>>>Coke will start maintaining the machine when the current supply of product has been used;

>>>AEP will be switching out the security lights soon;

- >>>An engineer's drawing to scale for the proposed activity building was presented to the board; volunteers to work on the building were asked to sign up;
- >>>The board will be looking for an individual to wash the roof of the clubhouse;
- >>>The possibility of moving the exercise room to the annex and the purchase of a new flat screen TV was discussed;
- >>>An "HVR Who's Good List" regarding reputable businesses and services in the valley similar to the "Craig's List" will be worked on during the summer;
- >>>Concern was raised by the Creative Sewing group regarding their electric outlet needs if possible renovations are made to the clubhouse;
- >>>An opposing position regarding the controversial use of tables for game playing on Sunday nights;
- >>>A question was raised about the use of the library.

>>>To approve the amount of \$790.00 to replace the carpet on the stage floor and on the upper half of the wall for sound proofing;

>>>To approve the amount of no more than \$125.00 to purchase a new CD player for the water aerobics class.

## HIGHLIGHTS OF MINUTES OF BOARD OF DIRECTORS MEETING

March 23, 2012

General announcements and information:

- >>>AEP changed the street lights to 1000 watts;
- >>>A solar light has been placed on the flag;
- <<< A proposed renovation of the present pool hall is posted in the clubhouse;
- >>>The NuStep Committee proposed a Jack of Spades 50/50 fund raiser and will contact the HVR attorney regarding compliance with state law;
- >>>The previous cleaning of the roof was \$500.00; the service agreed to clean the roof for \$400.00 once a year or \$300.00 each to clean it twice each year
- >>>A request to have large items picked up once each month was made; an investigation will be made; >>>It was decided not to have the boulevard palm trees trimmed at this time;
- >>>The possibility of installing a video screen in the clubhouse was discussed and will be investigated by the board;
- >>>The "Who's Good List" has been created and is now available on the HVR website for members to provide information on Valley goods and services that they recommend;
- >>>Moving of the bingo board will not be decided until action on the proposed activity building has been decided.

#### Motions made, seconded and carried:

- >>>To approve the cleaning of the roof bid of \$300.00 each and to have it cleaned in April and in September;
- >>>To pay the engineer no more than \$800.00 for the work that is required to keep the project moving forward;
- >>>To leave the bathrooms and laundry room open for telephone access to meet county pool requirements;
- >>>To delay any decision to move the exercise room to the annex until action on the proposed activity building has been decided;
- >>>To delay any deicision regarding the approval of the amount of \$1,894.37 for recovering all the pool tables in the poll hall until action on the proposed activity building has been decided;

>>>To have the pool area cleaned throughout the summer by the pool service at a cost of \$60.00 per month which includes cleaning supplies.

### HIGHLIGHTS OF MINUTES OF BOARD OF DIRECTORS MEETING

October 11, 2012

**G**eneral announcements and information:

- >>>An agreement has been made to have the clubhouse roof cleaned twice a year at a cost of \$600.00 total:
- >>>The clubhouse will be closed from Friday, October 19, through Sunday, October 21, to have the floor cleaned and waxed;
- >>>Signs where made for the swimming pool stating that it is to be used only by HVR residents;
- >>>Discussion was held regarding the repair and/or purchase of a new HVR sign for the clubhouse.

#### Motions made, seconded and carried:

- >>>To accept the Dispute Committee's recomendation to deny the request of Mr. and Mrs. Sprouse to raise their awning above the 14'6" but to allow them to raise the west edge of the awning to allow for more height;
- >>>To move the shut-off valve on the clubhouse stove to a place where it is more accessible so it can be shut off when not in use;
- >>>To have Louie Cagler water the public area plants during the summer season and have Mrs. Perex do so in his absence;
- >>>To allow produce sales in the park;
- >>>To appoint Bobbie Bradshaw to fill the vacancy caused by Mike Yost's resignation until the elections in January.

## NOTICE TO MEMBERS OF HIDDEN VALLEY RANCH PROPERTY OWNERS' ASSOCIATION

In accordance with ARTICLE XI, AMENDMENTS, Section 1, Power of Members to Amend Bylaws, you are hereby notified that the following proposed bylaw amendment will be presented for approval at the **November 10, 2012**, general membership meeting of Hidden Valley Ranch Property Owners' Association.

#### **CURRENT BYLAW:**

1

I

**ARTICLE IV.** Meeting of Members

SECTION 5. Quorum. Thirty-five percent (35%) of the members of the association whose dues and assessments are paid must be present in person at all regularly scheduled and special meetings to constitute a quorum to legally transact the business of the association. In the absence of a quorum, the only business that can be transacted is (a) the taking of measures to obtain a quorum; (b) fixing a time to which to adjourn; and (c) to adjourn, or to take a recess. Amended March 2005 and March 2009.

**CHANGE:** Omit in its entirety and substitute the following therefor.

#### PROPOSED BYLAW:

**ARTICLE IV.** Meeting of Members.

SECTION 5. Two Hundred and Fifty (250) members of the association whose dues and assessments are paid in full must be present in person to constitute a quorum at all regularly scheduled and special meetings to legally transact the business of the association. In the absence of a quorum, the only business that can be transacted is (a) the taking of measures to obtain a quorum; (b) fixing a time to which to adjourn; and (c) to adjourn, or to take a recess. Amended March 2005 and March 2009.

**REASON FOR CHANGE:** To reduce the number of members required to constitute a quorum.


