NOTICE TO MEMBERS OF HIDDEN VALLEY RANCH PROPERTY OWNERS' ASSOCIATION

In accordance with ARTICLE XI, AMENDMENTS, Section 1, Power of Members to Amend Bylaws, you are hereby notified that the following proposed bylaw amendment will be presented for approval at the **December 8, 2012**, general membership meeting of Hidden Valley Ranch Property Owners' Association. **CURRENT BYLAW:**

ARTICLE IV. Meeting of Members

SECTION 5. Quorum. Thirty-five percent (35%) of the members of the association whose dues and assessments are paid must be present in person at all regularly scheduled and special meetings to constitute a quorum to legally transact the business of the association. In the absence of a quorum, the only business that can be transacted is (a) the taking of measures to obtain a quorum; (b) fixing a time to which to adjourn; and (c) to adjourn, or to take a recess. Amended March 2005 and March 2009.

<u>CHANGE:</u> Omit in its entirety and substitute the following therefor.

PROPOSED BYLAW:

ARTICLE IV. Meeting of Members.

SECTION 5. Two Hundred and Fifty (250) members of the association whose dues and assessments are paid in full must be present in person to constitute a quorum at all regularly scheduled and special meetings to legally transact the business of the association. In the absence of a quorum, the only business that can be transacted is (a) the taking of measures to obtain a quorum; (b) fixing a time to which to adjourn; and (c) to adjourn, or to take a recess. Amended March 2005 and March 2009.

REASON FOR CHANGE: To reduce the number of members required to constitute a quorum.

- *The cards from a regular deck of play cards (minus jokers and deuces) will be placed in individual sealed envelopes.
- *They will then be shuffled so no one knows which card is in which envelope.
- *These envelopes are then locked in a case which will remain the H.V.R. office.
- *The committee will sell raffle tickets at \$1.00 each which will be placed in the weekly drawing that will take place at Hidden Valley Ranch on Thursday at 12:30 p.m.
- *The raffle ticket that is drawn will tell us the weekly winner who will then choose an envelope.
