

 - February 7, 2014
- Announcements and information:
- >>>Six assessments are outstanding.
- >>>Steve Freilinger reported that the Architectural Committee brought three issues before the Board. (a) A request to define the distance from the back of the lot seeking a standard number for each member's lot restrictions; Steve proposes that the formula not be changed but to go through every lot and establish the number; he will work on the map this summer; (b) Awning height definition-measure from front or back; the back height needs to be 13.6". (c) Notification on the new county permit form as it asks for the number of bedrooms.

- >>>Discussion was held regarding the policing of lots during the summer. It was determined that a Covenant Enforcement Committee had been formed and they will be working with the Rules Committee to establish procedures to be effective this fall. The Board will continue to police lots in the interim.
- >>>A volunteer is needed to do the laundry from the kitchen; Karen Freilinger volunteered for this duty.
- >>>The Heart Rangers need a more durable map.
- >>>A request was made for a park entrance sign.
- >>>Joe Roberts advised that the HVR Chapel wants to donate two televisions to be used as a message center.
- >>>Ken Sutter has been looking at the Hobart website for replacement appliances.

- >>>To appoint Rick Radl to fill the unexpired term of Nathan Holland who recently resigned.
- >>>To create a Fitness Room Committee with Bill Anderson as chair.
- >>>To contract for one year for a dedicated host for the website.
- >>>To provide WIFI for the clubhouse on a trial basis.

- >>>President Reiland reminded members that they needed to complete the Summer Lot Cleanup Form and turn it into the office.
- >>>Gary Kienast, Vice-President, advised that he had been unable to reach Barry Lewis regarding the grant situation and that there was no word on the status of the government funding allocations.
- >>>Karol Lippert, Secretary, reminded everyone of the HVR/LVR street dance on Sunday, February 16, and that the 2014 park directory is now available.

- The following committee reports were made:
- >>>Bill Eck reiterated the need for members to call the Heart Rangers when there is an emergency so they can assist the ambulance.
- >>>Ken Sutter announced that he would be retiring as chairman of the Dance Committee. Dances for next year have been scheduled.
- >>>Rita Cepress thanked all who supported the chicken dinner. She presented the board with a check in the amount of \$200.00, announced that they would be purchasing something for the kitchen and would donate the rest of the proceeds to charity.
- >>>Jim Moore, Board/Craft Show Liaison, reported that the chairman and her committee had resigned, that Lila Helm is the new chair and that Steve and Diane Larsen would be making the food for the show.
- >>>Joe Roberts, representing the HVR Chapel Committee, announced that they would be contributing a wall-mounted TV to be used as a message center.
- >>>Webmaster Ray Fink advised that wifi is now available in the clubhouse and the password is posted in the library. Also, improvements have been to the website to improve the sending of emails.

- >>>Lew Fry, Travel and Tour Chair, reported on the play at STC on February 28 and the shrimp boil on a shrimp boat near Brownsville.
- >>>Bill Anderson, NuStep Committee Chair, stated that the committee has decided to sell tickets every day from 9:00-11:00 a.m. and elected to have a "draw off" of the Jack of Spades if it is not won during the street dance on Sunday, February 16. <u>IMPORTANT NOTICE !!</u> YOUR VOTING RIGHTS & RESPONSIBILITIES*

Voting isn't just a right of membership; it's your duty to vote when you have an opinion about a matter being decided. You all know how important one vote can be. By failing to vote, you allow others to make the decision, which is the same as having voted for the prevailing side. Whether you vote or not, you're still in some way responsible for the decision that's made.

Although it's your duty to vote when you have an opinion, you can't be forced to vote. You have the right to remain neutral. In fact, some situations demand that you refrain from voting even if you have a legal right to vote. The abstention rule is a should rule. Just as you can't be forced to vote, you can't actually be compelled not to vote.

Abstentions do not count. If you abstain from voting, you have not voted. The fact that you were in the room doesn't make any difference unless the result is based on the number of members present. Figuring abstentions into vote totals or noting them in the record is never correct unless the vote is a roll-call vote. Then, it's only important that the records shows you were present. Your abstention still doesn't count as a vote.

Key points in counting ballots: (1) Blank votes are treated as scrap paper and don't count at all; (2) Each question on a multipart ballot is counted as a separate ballot. If a member leaves one part blank, the votes entered on the other question aren't negated; (3) If a member votes for few choices than positions to be elected, the vote is not illegal; (4) Small technical errors, such as spelling mistakes or marking an X when a checkmark is called for, don't make a vote illegal as long as the voter's intent is discernible.

(*The above information was obtained from Roberts Rules for Dummies, a clear, easy-to-use guide that makes parliamentary procedure simple to understand and apply.)

(H.V.R. Bylaws require a simple majority of votes (MORE THAN HALF) to pass ordinary motions and bylaw amendments may be adopted by two-thirds of the quorum.)

<<< Activity Coordinator >>>

All groups that have held their activity on the same day(s) of the week or the same day of each month (i.e. second Monday), at the same time and at the same place, WILL NOT have to submit any paperwork to schedule their activity in the future. These activities will automatically be included on the new season's calendar. Of course, if a new chairperson has been named, the office should be contacted immediately by submitted a Request for Use of the Hall and/or Annex indicating the name and telephone number of the new chairperson.

All proposed NEW activities or special events MUST be approved by the Activity Coordinator to ensure that conflicts do not arise. All NEW activities will be scheduled on a first come-first served basis.

NOTE: The chairman of an event or function scheduled in the Hall <u>is responsible</u> for contacting a member of the Maintenance Committee *in advance* of the event so that the air conditioning/heating can be adjusted accordingly. If the audio system is required, complete the applicable section of the Request for Use of Hall

The Architectural Committee will meet during the winter (October to March) every Thursday morning at 9:00 a.m. During the summer they meet as requested.


The question most commonly asked is: Who needs to consult with the committee? Answer: Anyone doing exterior changes to their property. Examples: Awning (free-standing or attached – all sizes, which includes percolas and gazebos), decks and handicap ramps.

If you now have a patio and wish to enclose it, you will need a permit. Anytime you pour concrete and do framing, YOU NEED A PERMIT. For dimensions, restrictions and other information, start by picking up the questionnaire packet located in the bottom rack of the plastic stack on the office counter. If you still have questions, contact any member of the Architectural Committee or come to the meeting on Thursday morning so you can be helped.

The procedures to follow are simple:

- 1) Pick up packet from the office:
- 2) Complete; sign forms in BLUE ink only; TAKE ALL FORMS TO THE H.V.R. ARCHITECTURAL COMMITTEE MEETING FOR APPROVAL. (Meeting day is Thursday at 9:00 a.m.):
- Take packet contents to Hidalgo County Planning Dept. along with a copy of your property DEED and documentation of WA-TER HOOK UP to obtain permit;
- 4) Submit a copy of the permit to the office or to the Committee;
- 5) NOTIFY the Committee when mobile units are scheduled to be set up, when an awning frame is being started and when pouring of concrete is scheduled;
- 6) Notify the Committee when the job is
- 7) Completed for a final sign off.
