The meeting agenda will be posted following the Board of Directors' meeting on Friday, November 13, 2015, at 9:30 a.m.

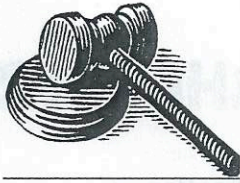

GENERAL MEMBERSHIP MEETING
February 14, 2015**

Quorum requirement 269; number in attendance 298. The meeting was called to order at 9:04 a.m.

The minutes of the January 10, 2015, general membership meeting were approved as posted.

Bob Arnold, treasurer, reported as follows: Operating fund balance \$117,109; total assessments received \$136,800; savings account balance \$21,000. Year to date figures: income \$140,776; expenses \$9,071; and net income/loss \$131,705. The report is posted and subject to audit. Bob also reported that the IRS audit for 2012, which was completed on August 29, 2014, was approved and that no taxes or penalties are due.

The following committee reports were given:

- >>> Dick Harris, Rules Committee Chair, explained the voting provisions regarding Article 4, Section 5 of the bylaws;
- >>> Ray Fink reported that the wife and IC8 is currently being reviewed by the board;
- >>> Margie Ford reported on the beautification committee and asked for volunteers;
- >>> Don Leonard, Heart Rangers, reported that one call was received last month and that 88 calls were answered since 2006.

Dick Harris, Rules Committee Chair, moved the proposed bylaw amendment to Article IV, Section 5, regarding the quorum be adopted. Following discussion, President Kienast requested that members mark their ballots. Results of voting: Yes 132; no 77; (number of votes required for passage 149); failed.

The meeting was called to order at 9:00 a.m.

The minutes of the February 14, 2015, general membership meeting were approved as posted.

Bob Arnold, treasurer, reported as follows: Operating fund balance \$95,773; total assessments received \$139,500; savings account balance \$40,000. Year-to-date figures: income \$8,017; expenses \$11,823; and net income/loss -\$3805. The report is posted and subject to audit. Bob also reported that another open house was scheduled for March 19; so far 8 properties have been sold.

- >>>John Crawford, liaison with the Swimming Pool Committee, explained to the membership the process of switching the water in the pool to "soft water";
- >>>Dick Harris, Rules Committee Chair, reported that the committee was withdrawing the proposed bylaw amendments until the fall of 2015;
- >>>Donna Smith announced that the summer residents' meeting was to be held at 9:00 a.m. on March 23, 2015.

***Groups that have held their activity on the same day(s) of the week each month (i.e., second Monday) at the same time and at the same place **DO NOT** have to submit annual paperwork; the activity will automatically be included on the new season's calendar.

If a new chairperson has been named, the office should be notified immediately by submitting a Request for Activity Space form indicating the name and telephone number of the new chairperson.

All proposed **NEW** activities or special events **MUST** be scheduled by the Activity Coordinator to ensure that conflicts do not arise.

Architectural Committee

The Architectural Committee will meet during the winter months starting October 15, 2015, and will meet every Thursday morning at 9:00 a.m. in the meeting room next to the outer office.

The question most commonly asked is: Who needs to see the committee? The answer is: Anyone who is doing exterior changes to their property. Examples: Awnings (free-standing or attached; full lot or small including percolas and gazebos), decks and handicap ramps. If you currently have a patio and wish to enclose it, you will need a permit. Anytime you pour concrete and do framing **you** need a permit! For dimensions, restrictions and information, start by obtaining the questionnaire packet from the office. If you have questions, contact anyone on the committee or come to a meeting on Thursday morning so we can answer your questions.

The procedure to follow is simple: (1) Obtain a questionnaire packet from the office; (2) Complete the forms and sign in **BLUE** ink; (3) Attach a copy of your property deed and proof of water hook-up and submit all documentation for approval to the Committee; (4) Take all documentation to the Hildago County Planning Department and obtain a permit; (5) Submit a copy of the permit to the office or to a committee member; (6) Notify the committee when mobile homes are scheduled to arrive in the park, when framing is starting for an awning and when pouring of concrete is scheduled;

(7) Notify committee when job is complete for final sign-off.

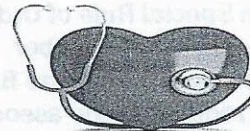

VETERANS DAY

World War I - known at the time as "The Great War" - officially ended when the Treaty of Versailles was signed on June 28, 1919, in the Palace of Versailles outside the town of Versailles, France. However, fighting ceased seven months earlier when an armistice, or temporary cessation of hostilities, between the Allied nations and Germany went into effect on the eleventh hour of the eleventh day of the eleventh month. For that reason, November 11, 1918, is generally regarded as the end of "the war to end all wars."

In November 1919, President Wilson proclaimed November 11 as the first commemoration of Armistice Day with the following words: "To us in America, the reflections of Armistice Day will be filled with solemn pride in the heroism of those who died in the country's service and with gratitude for the victory, both because of the thing from which it has freed us and because of the opportunity it has given America to show her sympathy with peace and justice in the councils of the nations..."

The original concept for the celebration was for a day observed with parades and public meetings and a brief suspension of business beginning at 11:00 a.m.

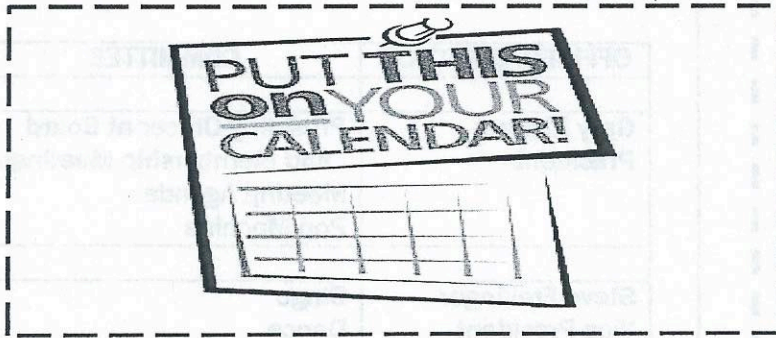
