1. **Travel Documents** – U.S. and Canadian citizens are required to have a valid passport, and the passport must be valid six (6) months from your March 24, 2013 return date (e.g., valid past Sep 24/2013).
2. **Pricing** – Royal Caribbean Cruise Lines (RCCL) reserves the right to add-on a fuel surcharge for all guests at up to \$10 per Person per Day up to a maximum of \$140 per Person for the cruise, if the price of West Texas Intermediate fuel exceeds \$65 per barrel.
3. **Arrangements** – The cruise vacation price is based on a minimum participation of 30 paying passengers and it includes entertainment, planning, and operational charges in effect at April 01, 2012.
4. **Reservations** – a confirmed reservation is defined as a completed Registration Form and the required \$250 deposit payment at the time of Registration. The registration requires your legal name: First – Middle - Last Names as they appear on your valid passport along with your Date of Birth. **PLEASE NOTE:** once a cruise reservation has been made, then any name changes or corrections to the spelling of names may result in a change fee, which is solely the responsibility of the passenger.
5. **Travel Insurance** – you have been given the option of purchasing travel insurance for covering trip cancellation, lost baggage, and medical emergencies at the time of signing-up for the trip. The insurance does not cover a cancellation by you for non-medical reasons. 6. **Cancellation** – a cancellation penalty of \$100 per Person will apply from the date of sign-up until November 15, 2012 (final payment date); from November 16, 2012 to December 31, 2012 a cancellation penalty of \$250 per Person will apply; from January 01, 2013 to January 20, 2013 a cancellation penalty of 50% per Person will apply; from January 21, 2013 to February 17, 2013 a 75% per Person cancellation penalty will apply; and from February 18, 2013 to March 17, 2013 (departure date) a cancellation penalty of 100% per Person will apply. Because cancellation penalties apply, it is strongly recommended to protect your investment with travel insurance.
