**H-I-G-H-L-I-G-H-T-S OF MINUTES OF  
NOVEMBER GENERAL MEMBERSHIP MEETING**

**Saturday, November 14, 2009**

The meeting was called to order with 302 members present; number required for a quorum was 284.

Treasurer's Report as of October 31, 2009, was read by Bud Remington as follows: Checking account balance \$12,221.25; money market operating account balance \$35,445.02; and money market reserve account balance \$67,127.24.

The office will not accept any bills larger than \$20.00. Last February Tom Forbish filled out some paperwork to seek a tax refund from the former H.V.R. utility provider, which resulted in a refund \$9,600.00. When H.V.R. changed utility providers there was an early cancellation charge of \$6,000.00; to date we have saved \$5,713.00 on electricity charges. However, the year-to-date electricity expense was \$32,828.00; the 2008 electricity expense was \$29,415.00 for the same period. (Ken Sutter will review the electricity bills to try to determine the reason they are so much higher than expected.)

H.V.R. has been paying sales tax since 2002. The State of Texas recommends that we give a receipt for all sales made and indicate the amount of sales tax. The association must abide by the state laws. The cash registered purchased this summer is only a tool to make it easier to calculate the amount of tax owed to the state. Paper receipts may be used instead.

Last March H.V.R. received a letter from the park insurance carrier advising of the Virginia Baker Law, which states that even though the swimming pool is privately owned guests are allowed to use it and, therefore, H.V.R. must follow the provisions of the law. Anyone wishing to read the full particulars may ask to see it at the business office.

Bids were requested in regard to necessary swimming pool repairs. Hamlin pools was the low bidder; the cost to repair the drains in the pool was \$1,500.00; the hot tub repairs were \$1,450.00; the outer plaster inside the pool was repaired at a total cost of \$2,750.00.

An I.R.S. audit was conducted on November 10 with Tom Forbish assisting Bud Remington. The agent determined that some events held at H.V.R. were subject to federal revenue tax because they are open to the general public. The park non-profit status regarding taxes on revenue is subject only to members. As a result Tom Forbish volunteered his time to complete the required forms which resulted in a tentative tax

due of approximately \$900.00 plus interest and penalty. The audit was triggered by a Form 4720 filed with the regular 990 in 2005 which indicated no income.

Since H.V.R. has not had a dues increase for several years, expenses have risen and a cushion should be held in reserve for major repairs, it was decided by the Board, that dues should increase to \$350.00 annually effective January 2, 2009.

It was announced that the Board has met with the collection attorney recommended by Mr. Ochoa. Additional documentation is required before commencing with the collection and will be provided by Mr. Ochoa.

Clarification was requested regarding the expenditures in the billiard hall. It was explained that general maintenance is considered repair so that replacement isn't necessary and capitol improvement is replacement.

The election of directors to fill the unexpired terms of Mike Coon and Ann Neuenschwander was held. Connie Mader was nominated to be on the ballot to replace Mike Coon along with Marvin Rahn. Roy Sexton and Judy Lungo were on the ballot to replace Ann Neuenschwander. Members were instructed to vote.

Election tally results:

Director term ending January 2010: Roy Sexton 185 votes, Judy Lungo 123 votes; winner Roy Sexton.

Director term ending January 2011: Marvin Rahn 160 votes, Connie Mader 141 votes; winner Marvin Rahn.

A motion was made and seconded as follows: "The officers/directors may determine any necessary annual assessment approved by the officers/directors. After the board has made this determination the proposal should be put to a vote of the general membership". The parliamentarian stated that notice of proposed bylaw amendments must be given prior to voting on the amendments. It was then ruled by the parliamentarian that the amendment was in direct conflict with the covenants and, therefore, invalid.

The Parliamentarian explained that covenants require the Board to levy and collect the dues, not the bylaws and the covenants supersede the bylaws in this case.

A motion was made and seconded that none of the dues increase monies be spent without membership approval. Since several members had left the meeting a quorum was lost and since, according to the bylaws, a quorum must be present to conduct all legal business, no action was taken on the motion.

**HIGHLIGHTS OF MINUTES OF BOARD OF DIRECTORS MEETING**

Monday, November 3, 2009

**General Information and announcements:**

>>No progress in regard to the swimming pool lift;  
>>New chairs for the Clubhouse will be shown at the December general membership meeting;  
>>Several new recruits are needed to join the Heart Rangers and CPR training will be required;  
>>The office computer needs to be replaced or upgraded;  
>>Discussion was held in regard to the formation of a Rules Violation Enforcement Committee to assist the Board and the Architectural Committee following a meeting with the park attorney regarding proper procedures to follow to enforce the subdivision covenants. Violators will have ten days to correct the violation in question; if violators refused to take corrective measures, they will then have ten days to contact the Dispute Committee. Following a determination by the Dispute Committee, a registered letter should be sent to the violator; thereafter the matter should be turned over to the park attorney for legal action.  
>>The park attorney is checking with the county in regard to new "homeowner association" laws recently enacted by the State of Texas.

>>To provide up to \$300.00 for training new recruits for the Heart Ranger program;  
>>To sell the javelina trap to John Gaddis for \$125.00 with the understanding that H.V.R. can borrow it at any time if needed;  
>>To have the swimming pool open from 8:00 a.m. to 1:00pm for planned activities such as exercise class and open from 1:00 p.m. to 1:00 a.m. for the enjoyment of all members with no group activities scheduled during this time, except that water volleyball which is held on Tuesdays and Thursdays from 1:00-3:00 p.m. is an exception because this activity is grandfathered in;

>>To approve the appointment of Lucy Cagler to chair the Tuesday morning "Coffee Talks";  
>>To approve the appointment of Bob Dudeck to chair the Rules Violation Enforcement Committee.

**Motion made, seconded and failed:**

>>To deny the request of Wanda McGill to have coed water aerobics on Mondays and Thursdays from 4:00-5:00 p.m.

The meeting adjourned at 9:45 a.m. to go into closed session. The meeting reconvened at 10:20 a.m.
