TRAVEL DOCUMENTS: U.S. and Canadian citizens are required to have a valid passport to take this vacation.

ARRANGEMENTS: The vacation price is based on a minimum participation of 30 persons and includes planning and operational charges and is quoted on the current tariff rates in effect as of February 28, 2011.

RESERVATIONS: Legal first and last names are required (identical to your passport). Once cruise reservations have been made, if a name change is required because of incorrect information supplied to our office, the client is responsible for any applicable charges.

TRIP CANCELLATION, BAGGAGE AND MEDICAL INSURANCE: You have been given the option of purchasing trip cancellation, baggage and medical insurance at the time you sign-up for the tour.
